

TEAM.card - General Terms and Conditions (GTC)

The Tourismusverband Tiroler Oberland (hereinafter referred to as "TVB") offers all employees, managers and owners of businesses located in the Nauders - Tiroler Oberland - Kaunertal region and who are compulsory members of the TVB Tiroler Oberland the free purchase of the TEAM.card (hereinafter referred to as "entitled persons"). On presentation of this TEAM.card, the entitled persons receive discounts in numerous partner companies of the TVB Tiroler Oberland until revoked at any time.

A form to apply for the TEAM.card can be filled out by entitled persons either on the website of the TVB Tiroler Oberland at jobs.tiroler-oberland.com or in paper form at the offices of the TVB.

The TEAM.card will be issued by the TVB after the form has been filled out completely (online or in paper form) and after confirmation that the applicable GTC have been accepted. With regard to the processing of personal data, reference is made to the privacy policy of the TVB

When handing over the TEAM.card, a confirmation of receipt must be signed.

The TEAM.card is valid from October 1 to September 30 of the following year. Upon expiration of this period, a new application and issuance is required. The TEAM.card is not transferable and is only valid with the presentation of a valid official photo ID.

Any statements made in brochures, on the websites of the TVB Tiroler Oberland and in other advertising material with regard to the benefits associated with the TEAM.card are merely non-binding information. Therefore, there is no right to the benefits listed in the information material. In particular, the TVB shall not be liable should a partner company fail to provide the benefits listed by the TVB.

The TVB acts only as an intermediary between the beneficiaries and the partner companies. The TVB collects the offers of the partner companies, publishes them (on the Internet, brochures, social media, etc.) and issues the TEAM.card. However, the TVB does not conduct any transactions in connection with the TeamCard.

The contracts concluded in connection with the TEAM.card are exclusively between the cardholder and the respective partner company. The TVB is not a party to these contracts. Contracts for services of the partner companies are therefore exclusively subject to the conditions, including the general terms and conditions, of the partner companies. The TVB is not liable for the contractual fulfillment of these contracts and/or for any damages that may result from them.

After termination of the employment relationship that entitled the holder to obtain the TEAM.card, as well as in the case of a business owner leaving the TVB, the TEAM.card automatically loses its validity and may no longer be used. The termination must be immediately reported to the TVB in

writing by the entitled person and the TEAM.card must be returned either to the employer or directly to the TVB. The loss of the TEAM.card must also be reported immediately to the TVB.

Austrian substantive law shall apply exclusively. The exclusive place of jurisdiction for disputes arising from a contractual relationship between the entitled person and the TVB is the competent court in whose district the entitled person has his habitual residence (or registered office) or place of employment.
